- Director, NIH reserves the right to modify or cancel the advertisement/result partially and/or fully without assigning any reason thereof and the same shall be published in the Institute website only.
- Director, NIH reserves the right to cancel any and/or all the applications without assigning any reason thereof.
- **Age Limit:**
 - Not more than 67 years.
- **Engagement:**
 - The engagement will be made on hourly basis/on call basis
 - The engagement in the above-mentioned posts will be made only to meet the requirement due to additional activities in defined time frame.
 - The term of engagement shall ordinarily be for a period till **31/03/2027** or till further orders and may be extended subject to satisfactory performance and requirement of services.
 - The tenure will be from 01st April till 31st March of any given financial year. For engagements made midway through any financial year, their initial period of engagement will be till 31st March of that financial year.
 - The engagement in the above-mentioned posts will be purely on hourly basis/on call basis and will not confer any right for regular appointment in the Ministry/organization.
- **Remuneration:**
 - The amount of hourly remuneration shall be Rs.2,000/- per hour for maximum 4 hours/day and maximum 60 hours/month.
 - Shall not be entitled to any allowance such as TA, DA, HRA, residential accommodation, CGHS, Medical reimbursement, etc. and other financial benefits.
- **Scope of Consultancies/ Responsibilities:**
 1. Expertise will be utilized in patient care services like OPD, IPD and health camps, etc.
 2. Expertise will also be utilized for the teaching theory and clinical of UG and PG curriculum as and when required by the concerned department including in the compulsory research works of interns and PGTs.
- **Working hours:**
 - The working hour is maximum 4 hours/day and maximum 60 hours/month from Monday to Saturday. They may be called individually on Sundays or any holidays in case of urgency/as and when required.
 - They shall mark their attendance in AEBAS mandatorily, failing which it may result in deduction of remuneration.

➤ **Tax Deduction at Source:**

The Income Tax or any other Tax will be deducted at source as per Govt. instructions. Necessary TDS Certificate will be issued to that effect.

➤ **Confidentiality of Data and Documents:**

1. The Specialist will maintain absolute confidentiality and secrecy of the information handled by them. The secrecy and confidentiality are to be maintained even after the termination of the engagement.
